With the introduction of Adjudication in the proposed Security of Payment Legislation in Hong Kong, Adjudication is set to become the "first-tier" dispute resolution method in construction contracts. This short course will provide an overview of Adjudication, the Adjudication process and its strength and weakness in resolving commercial disputes.
