Mr. Man Sing Yeung is a practising arbitrator, mediator and construction lawyer in Hong Kong. He is accredited as a chartered arbitrator, chartered quantity surveyor and accredited mediator/adjudicator. Mr. Yeung was the former Chair of the Chartered Institute of Arbitrators (East Asia Branch), and the Hong Kong International Arbitration Centre - Hong Kong Mediation Council. He was a member of the Steering Committee on Mediation of the Department of Justice, HKSAR. He is now the Chair of the Law Society's Arbitrators Admission Sub-committee, and a director of the Asian Institute of Alternative Dispute Resolution, Malaysia. He has been involved in training arbitrators in Hong Kong and internationally including Afghanistan, Maldives, the Philippines & Sri Lanka. Having acted as an arbitrator for a fair no. of cases since 2000, he is with arbitral panels in China, Dubai, Hong Kong, India, Japan, Korea, London, Malaysia, Singapore and Taiwan; and being on mediation panels of different jurisdictions, he also mediates cases involving construction-related and cross border investment disputes. He acted for parties in arbitrations for Hong Kong infrastructural-related projects and Macau hotels, and recently in establishing an adjudication mechanism for Hong Kong security of payment legislation and preparing standard construction contract documentation for the public sector.
